

a message from our board chair and president & CEO

Our 2019 fiscal year was an exciting time of growth and change for our organization. After a comprehensive study that began in late 2017, the boards of the Meals on Wheels Agency, the Meals on Wheels Foundation and the Food Bank of WNY voted to join forces as a single nonprofit known as FeedMore WNY on February 27, 2019. With a mission of offering dignity, hope and a brighter future by providing nutritious food, friendship and skills training to our Western New York neighbors in need, FeedMore WNY was formed to tackle the root causes of hunger while better reaching underserved populations and more efficiently meeting the needs of the community.

By coming together as FeedMore WNY, Meals on Wheels and the Food Bank were able to achieve far more together than either organization could have hoped to accomplish apart. On October 28, 2019, FeedMore WNY expanded its home-delivered meal services to include the geography covered by the former Lockport Meals on Wheels. Also in 2019, FeedMore WNY secured a new contract to serve meals for Hamburg Adult Day Services.

While Meals on Wheels and the Food Bank operated as FeedMore WNY under a joint services agreement for the majority of the year, the New York State Attorney General officially approved the merger on December 31, 2019. With this approval, FeedMore WNY was able to operate under a unified set of policies, procedures and financials beginning January 1, 2020.

In this report you will see financial results for the Meals on Wheels Agency and the Meals on Wheels Foundation in 2019. You also will find an overview of our service numbers as they relate to our Meals on Wheels program of FeedMore WNY. We thank you for your continued support and generosity as we work to eradicate hunger in Western New York.




